EUROPEAN HEALTH INSURANCE

The European Health Insurance Card - EHIC (formerly E111) covers basic healthcare on short trips around Europe and is available free of charge. It covers emergency treatment and treatment for existing chronic conditions. It will not provide for specialist transport home or accommodation for a relative. For this you need private holiday insurance.

But what will happen on June 23rd. if the UK opts for the so called Brexit?

The answer seems to be quite complicated. The EHICs are valid in the European Economic Area, not just in the EU. The EEA was created in 1994 so that non EU countries such as Norway, Iceland and Switzerland could be allowed to participate in the European Common Market.

So it is possible that UK citizens could continue to use the EHIC. But it would depend upon the attitude towards Britain of the remaining EU

States. As one of the major net contributors to the EU it is unlikely that Britain would be viewed favourably by the remaining states if we left. In which case, the European health Insurance card might well become invalid.

Brexit might also mean that the UK leaves the EEA because one of the arguments for leaving is to better control our borders whereas the EEA membership rules require freedom of movement across those borders.

The UK could agree similar health cover with individual states within the EU but this would take time. So If you are travelling to Europe this year, your EHIC may not provide for your emergency health needs. So private health insurance may well become not only desirable but essential.
